FUTURE OF HALL PRIMARY SCHOOL SITE

A few points from Bob and David as discussion starters.

Current situation

- No significant recent action.
 - Museum, pre-school and men's shed successful.
 - \circ pre-school premises does not comply with relevant standards
 - museum needs greater certainty for occupancy and use of buildings
 - Some trees on site are near the end of their lives and pose a risk to public safety require replanting.
- ACT Government unlikely to have significant funding available in the near future.

Possible ideas (and issues) for the future

- Retain (and enhance)
 - \circ School Museum
 - Pre-School (and perhaps child care centre)
 - \circ Men's shed
 - Principal's cottage
 - Tennis court
 - Green space/Community gardens
 - Removal of temporary structures
 - A community facility
 - \circ shared use?
 - \circ artists in residence?
 - Hall Band store and practise building?
 - o Seniors' villas/end of life care villas
 - Parking
 - Ownership
 - VHDPA ownership of part or all of the site?
 - Private ownership of the child care centre and the villas? (may cover the cost of redevelopment)
- A 'green' site solar power, rain water, possibly re-cycling of storm water.
 Parking
