# 5. Agenda Items

#### 5.1 Hall Recreation Trail

As Ben McHugh was unable to attend the meeting there was discussion on how to progress this topic. There was some discussion about how the decision to not approve the track came about.

John read from an email from Heritage to TCCS regarding the Hall Creek bike track decision -

"Council business in relation to this decision was conducted via out of session assessments by members of the Aboriginal Taskforce; therefore meeting minutes are not applicable on this occasion"

John remarked that it was unusual that decisions were made with no details relating to an agenda, minutes, when and where meetings were held, and who attended. Peter T remarked that this often occurred where indigenous matters and cultural sensitivity were involved. John then remarked that this sounded similar to the Hindmarsh bridge issue, involving "secret women's business".

Peter T then indicated that the VHDPA had no intention of taking on Heritage or TCCS, and that we should wait until a TCCS representative attended the next committee meeting in February to discuss what options are available. The committee accepted this decision.

John then mentioned that a TCCS online survey indicated 90% of Hall residents wanted a children's bike track, and 80% wanted the Gladstone St location - Option E. Ken disputed the accuracy of this survey and said that at a second meeting at the Pavilion, that 46.4% preferred Option E.

Peter remarked that in both surveys, the number of actual participants was very low - 68 responses to the TCCS online survey and 56 Hall residents for the second survey-given that there are approx 300 people living in Hall.

Following the above discussion it was agreed that as the VHDPA were not the proponents in this case the committee would not take any action in this regard. The committee agreed that it would wait and see the information Ben is able to provide at the meeting in February

# Hall School Museum and Heritage Centre

The Museum is currently working with a well-known heritage consultant, Dr Ros Russell, to prepare a national significance assessment of the Gillespie Collection. We are fortunate that Neil Gillespie, son of Lyall Gillespie, will shortly visit the Museum to provide his personal perspective on this.

The Hall's Creek Geomorphology Project is well under way. Museum volunteers were given a briefing on 5 December by the consultants as well as representatives of two local Aboriginal organisations, and a report is expected in the New Year.


A late e:mail was received from Jonathan Palmer offering comments on destruction of heritage property at 8 Palmer Street in 2017.
