4. Reports of VHDPA Subcommittees

a. Hall Heritage Centre

The IT upgrade is with grant funds is nearing completion with new equipment having been purchased and being installed.

There are a couple of school visits happening each week.

The Brass in the Grass Band concert is scheduled for 15 October.

A contracted company has done a thorough clean of the buildings.

b. Hall Men's Shed

The deck platform has been completed and is being used for the monthly barbeque. The railing is still to be installed but the weather has not been conducive to much outside work.

c. Hall Facilities - Pavilion and Cottage

The Pavilion is running smoothly and continues to have strong bookings with strong forward bookings. Margaret Monahan is managing the cottage pending new arrangements.

The facilities group has met and has recommendation for the Committee to review at the next meeting.

5. Other Business

a. Wallaroo and Region Update

Toni Makkai reported that conversations with Wallaroo residents have heard mixed views about a recycling transfer station facility in the Wallaroo area. Apparently a few years ago there was a recycling skip in Wallaroo and the experience was very negative where it became a dump.

Toni expressed concern over the proliferation of feral animals – pigs, deer and goats – in Wallaroo and the Murrumbidgee corridor. The Committee agreed to request assistance from the NSW Environment Minister, the Goulburn MP and from Federal Member for Eden Monaro. Toni will draft a letter to be sent.

b. Cycle Path

The correspondence was noted with Minister Steel following the announcement of cycle path funding in the ACT budget. Lee-Ann Brodrick noted that the link with Pedal Power was proving valuable.

c. Lease renewals - Pavilion and Hall School site

Robert Yallop reported that there had been no response from Luke Halpin of ACT Sport and Rec on the Pavilion lease in spite of a request for an update.

Robert Yallop also reported a conversation with Ann Averill of ACT Property group that advised that the ACT government has decided not to do short term lease renewals for peppercorn leases but to maintain the "holding over" period of the leases until the new ACT government (after the 2024 election) does a review and determines the future arrangements.

It was agreed to seek advice from friendly local MLAs. It was also agreed to contact Heritage Minister Vassarotti and Phil Robson will prepare a draft letter.

d. Wind Up of Southwell Family Society

Ralph Southwell advised the Committee that the Southwell Family Society had held its special general meeting on 17 June and resolved to wind up the Southwell Family Society and resolved to transfer surplus assets on the winding up of the society to the VHDPA/ Hall Heritage Centre.

It was agreed that Ralph will work with the Hall Heritage Centre to create an inventory of physical assets being transferred. Phil Robson will notify Ralph of the bank details into which surplus funds are to be transferred.

Without Ralph Southwell or Tony Morris, Robert Yallop reminded the Committee that the Undertaking from the VHDPA to the Southwell Family Society had been unanimously agreed in email correspondence by all Committee members (except Ralph and Tony for whom this represented a conflict of interest).
